

ATC Annual Report 2021-2022

In total, ATC members met 32 times (mostly in person) during the 2021-2022 academic year, and the ATC chair met with other committees an additional 10 times, order to conduct our routine review of tenure files along with our other duties.

Tenure Cases

ATC completed the review of ten tenure cases. This process involved

- x reading the tenure dossiers of each candidate,
- x holding discussions on each candidate among the members of ATC,
- x meeting with Dean of Faculty/Vice President of Academic Affairs Michael Orr and Associate Dean of Faculty Paul Felling to discuss each candidate,
- x holding additional discussions among the members of ATC, and
- x sending ATC recommendations to president Conner.
