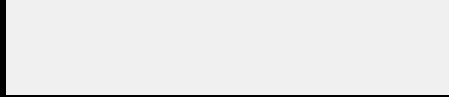

The mission of the Student Assessment and Intervention Group (SAIG) is to support the well-being and health and welfare of the community, by identifying individual students of concern in proactive and consistent ways so that the college can develop and deliver appropriate interventions. SAIG assesses statistical data and institutional patterns related to student behavior and well-being in order to insure that policies and practices are effective and in compliance with all relevant legal requirements.

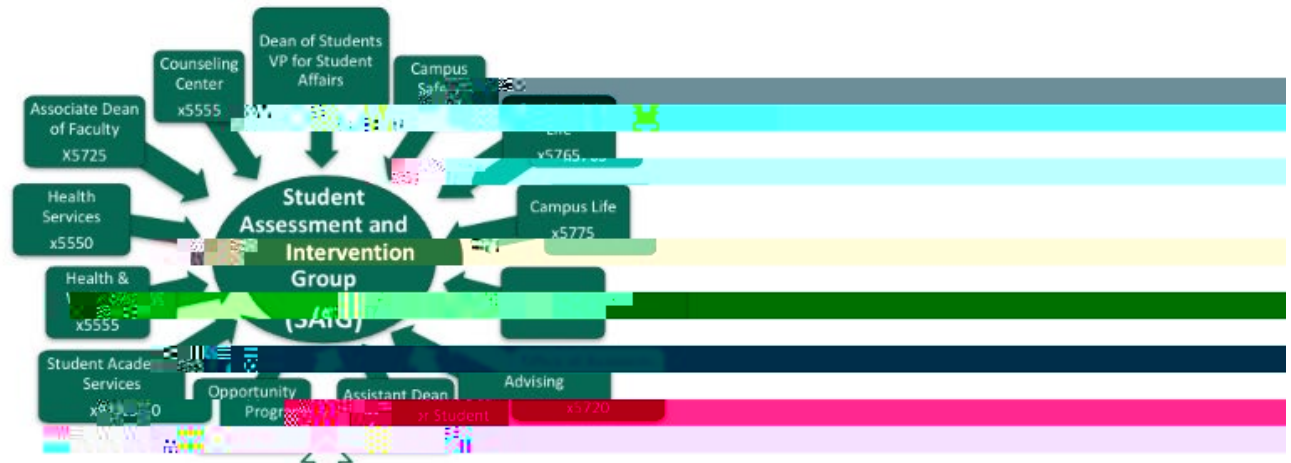
SAIG reports come to the group through a variety of channels, including, among others: Campus Safety Reports, Counseling Center Reports, and academic reports to the Office of Academic Advising, Student Academic Services, or the Director of the First Year Experience. Any member of the Skidmore community who is concerned about a student's well-being can generate a report about their specific concerns to SAIG ([link to report here](#)). SAIG also receives information from other

shared in full compliance with all relevant state and federal statutes involving the confidentiality of educational, medical, and mental health records.

Following a review and systematic assessment of each report, the group makes a decision about how to address the concern. This may include intervention to a specific group member or relevant staff members to support the individual student. The group also works to reinforce community standards of conduct to insure consistency across institutional responses over time. SAIG will continue to monitor situations involving students of concern over time to evaluate whether additional follow-up is needed.
